You are invited to participate in R.A.I.S.E. Mesquite Halloween Parade. There is no theme this year, just make your entries fun and lighted if you can. The staging area will be at the LDS Church North Parking Lot, located at 100 North Arrowhead Ln, beginning at 4:30p.m. Closing date for all entries will be Saturday, October 15th, 2021.

Parade rules:

1. Only vehicles in the parade may enter the staging area.
2. Entrants can sign up to have their entry judged.
3. All parade marshals and officials must be obeyed.
4. Parade entrants are expected to conduct themselves in a polite and congenial manner.
5. Twenty-five foot (25') spacing is required between all units.
6. Supply your own candy, plan on enough for 2500 kids if possible. Last year we ran out before we got to Yucca St., but we know a lot was given out at the front of the parade. This is an evening parade so NO throwing candy from floats or vehicles as children will run into the street and this puts them in danger. Please have people walk alongside you vehicle/float to toss candy to the kids.
7. Sound devices to amplify voice or music must be approved and not interfere with others.
9. R.A.I.S.E. Mesquite reserves the right to stop or remove from the parade any entrant performing any act or practice which, in the opinion of parade officials, is objectionable or creates a safety hazard.
10. No religious proselyting is allowed.
11. Alcohol is not permitted by any parade participant.
12. We recommend bringing water to drink for you and members of your group.
13. Please list type of entry: Walking/marching, Float, Vehicle, Band or Other. Check all that apply. We need to know the total number of vehicles.
14. Entries with animals MUST provide their own animal waste pickup.
